Contract Type: Fixed Term for as long as funding being available. The role will be reviewed and includes a probationary period of 6 months

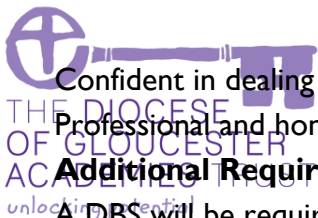

Our vision is rooted in our Christian foundation and our belief that all within our family should experience life in all its fullness.

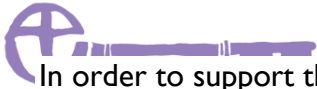
